- Applicant must be a high school senior.

## APPLICATION PROCESS:

- One scholarship will be awarded of \$1,000. Applications will be available at the high school guidance counselor office, from the Jackson County REMC office, or online at [JacksonREMC.com/seniorscholarship](http://JacksonREMC.com/seniorscholarship).
- Home schooled students, children of Jackson County REMC employees that are members, and directors children are also eligible.

## SELECTION PROCESS:

- Official grade transcript.
